

# **Privacy Notice**

At FIG Wellness Therapy, we are committed to protecting your privacy and ensuring the confidentiality of your personal information. This privacy notice outlines how we collect, use, disclose, and safeguard your personal data when you visit our physical therapy/occupational therapy clinic or use our services. We comply with data protection laws and regulations to safeguard your privacy rights. Please take a moment to review this notice to understand our practices regarding your personal information.

#### Information We Collect:

When you visit our clinic or use our services, we may collect the following types of personal information:

Contact information (such as name, address, email address, and phone number).

Medical information (such as medical history, diagnosis, treatment records, and health insurance details).

Financial information (such as billing and payment information).

How We Use Your Information:

We use your personal information for the following purposes:

Providing physical therapy/occupational therapy services and treatment.

Scheduling and managing appointments.

Billing and processing payments.

Ensuring the safety and security of our clinic and services.

Disclosure of Information:

We may share your personal information with third parties in the following circumstances:

With your consent: We may disclose your information to third parties with your explicit consent or at your direction.

Service providers: We may engage trusted third-party service providers who assist us in providing our services (such as medical documentation companies, billing companies, or IT support), subject to appropriate confidentiality obligations.

Legal requirements: We may disclose your information when required by law, court order, or government authorities.

Business transactions: In the event of a merger, acquisition, or sale of all or a portion of our clinic, your personal information may be transferred as part of the transaction.

#### **SMS/MMS Communications**

By providing your mobile phone number and consenting to receive SMS/MMS communications from FIG Wellness Therapy, you acknowledge and agree to the following privacy terms:

- 1. **Information Collection**: We collect your mobile phone number for the purpose of sending you appointment reminders, updates, and relevant information related to your care at FIG Wellness Therapy.
- 2. **Use of Information**: Your mobile phone contact information will solely be used to communicate with you regarding your health and wellness services.

- 3. **Third-Party Disclosure**: FIG Wellness Therapy respects your privacy. We do not sell, share, or distribute your personal information, including your mobile phone number, to third parties for marketing purposes.
- 4. **Opt-Out**: You have the right to opt-out of receiving SMS/MMS communications at any time. Instructions for opting out will be provided in our messages.

## Data Security:

We take appropriate measures to protect your personal information from unauthorized access, disclosure, alteration, or destruction. We implement industry-standard security practices and maintain physical, electronic, and procedural safeguards to protect your data.

We respect your rights regarding your personal information and are committed to protecting your privacy. These rights include:

Access: You have the right to request access to the personal information we hold about you. If you wish to review the information we have on file, you can request it.

Correction: If you believe that any of your personal information is inaccurate or incomplete, you have the right to request corrections or updates to it.

Erasure: Under certain circumstances, you have the right to request the deletion of your personal information from our records.

Objection: You have the right to object to the processing of your personal information in certain situations, such as for marketing purposes.

Restriction: You can request to restrict the processing of your personal information under certain circumstances, which means we will only store your data but not use it.
